The event occurred on 05/31/2020 at approximately 22:20 at MAZZA GALLERIE, 5300 WISCONSIN AVENUE NW, WASHINGTON, DC 20015

The offense occurred on May 31st, 2020, at 5300 Wisconsin Avenue, Northwest, Washington DC, PSA 202, approximately 2230 hours.

Officer Mullen and Officer Gibson were in full uniform and operating marked Scout Cars as 2023 and 2092 respectively. Officer Mullen and Gibson received a call for service concerning riotous acts at the listed location.

Once on scene, Officers Mullen and Gibson observed a large crowd of rioters approximately 200 in number. Officers Mullen and Gibson witnessed the same large crowd of rioters tear down plywood barriers and break multiple large windows in the 5300 Block of Wisconsin Avenue NW in order to enter and loot the stores. Approximately 30 rioters entered the rear of 5300 Wisconsin Ave (Saks Fifth Entrance) through a loading dock. Officers waited until the approximately 30 rioters exited the loading dock location with various clothing and items. The crowd of rioters saw police and began to disperse when D-1, D-2, and D-3 were stopped. D-1 was witnessed and stopped by Officer Mullen as D-1 was running away from the loading dock and attempting to pick up clothes that were dropped on the ground. D-2 was stopped by Officer Gibson and Ewald as she was exiting the store through the loading dock exit. D-3 was seen by Officer Gibson and Mullen as he was running out of the location with a large heavy bag of merchandise. D-3 threw the heavy bag of merchandise at Officer Gibson's upper body, making solid contact with Officer Gibson. Officer Gibson and Mullen then stopped D-3.

At 5300 Wisconsin Ave NW, Washington DC at approximately 2230 hours Officer Owens utilizing call sign 2082, operating vehicle 2073, received a radio run to assist units at the 5300 block Wisconsin Ave for juveniles rioting. Upon arrival to the scene Officer Owens witnessed a large gathering of rioters running toward 5300 Wisconsin Ave NW to destroy the glass door. Officer Owens and other officers began to run toward the crowd and witnessed D-4 kicking the window along with a large group of other rioters attempting to break the window. Officer Owens then took hold of D-4 and placed her under arrest.

D-1, D-2 and D-3 are all co defendants for rioting. The three defendants were all part of the approximately 200 rioters who participated in the breaking of windows and looting of multiple stores in the 5300 Block of Wisconsin Ave NW. This riot involved an assemblage of more than five people which by violent conduct created danger of damage or injury to property or persons.
